



## 4<sup>th</sup> HOSPICE KLANG CHARITY HUNT 2009

### INFORMATION, RULES & REGULATIONS

1. The event is a motor treasure hunt organised by Pertubuhan Hospis Klang (Hospis Klang) to be held on **Sunday, 19th April, 2009** to raise funds for its work. The route for the Hunt is expected to be in and around the Klang Valley.
2. Participating vehicles shall be motorised and travel on 4 wheels (excluding lorries and buses) having road tax and insurance valid as at the day of the Hunt.
3. Each team shall consist of a driver and navigator, with an option of no more than 2 additional passengers. The Driver and Navigator in each team must possess driving licences valid as at the day of the Hunt.
4. All team members must sign the Declaration and submit it together with the Entry Form and Entry Fees to the 4<sup>th</sup> Klang Hospice Charity Hunt Secretariat, Take A Break Events, No. 10, Jalan SS25/5, Taman Bukit Emas, 47301 Petaling Jaya. Take A Break Events is organizing the event free of charge for Hospis Klang and all Entry Fees will be remitted to Hospis Klang as soon as the event is over.
5. Entry fee per participant is RM90.00. Entry fee will entitle the participant to take part in the Hunt and a seat at the Prize Presentation Dinner to be held on the evening/night of the Hunt. Cheques for payment of Entry Fees are to be made payable to **Take A Break Events**. All cash payment of Entry Fees are to be paid by using on-line banking services to bank in your payment into **Malayan Banking Berhad Account No. 512231644851** of **Take A Break Events** or you may bank in your cheques in payment of Entry Fees into the said account. In either event you are to submit a clear copy of the bank-in slip as proof of payment with your completed Entry Form to Take A Break Events by post or by facsimile transmission.
6. Registration and Briefing for the Hunt will be held on 18th April 2009 at **Klang Executive Club, Persiaran Bukit Raja 2, Bandar Baru Klang, Klang, Selangor Darul Ehsan commencing from 2:00 p.m.**, unless otherwise notified. At least 1 team member from each team must attend the Registration and Briefing and he/she / they shall be responsible for disseminating all information provided at Briefing to all other team members.
7. Changes to entries after submission must be made by Briefing date and is subject to acceptance by the Organising Committee, otherwise teams will be deemed to comprise of the members stated in the Entry Form as at Briefing date.
8. All treasures and other materials submitted in the Hunt shall belong to the Organiser who shall be entitled to use the same as it deems fit and no team or member thereof shall have any claim thereto.
9. The team that scores the highest number of points in the Hunt less penalty points incurred will be declared the winner and all subsequent positions will be determined on the same basis. Tie-breakers in the event of a tie shall be as announced to the participants at the Briefing.
10. Car stickers as may be provided by the Organiser are to be placed on all participating vehicles for the duration of the Hunt.
11. The Organiser reserves the right without assigning any reason for the same to:-
  - (a) abandon, cancel or postpone the Event as deemed necessary;
  - (b) reject any Entry whether before or after the acceptance thereof;
  - (c) bar or exclude any one or more members from any team;
  - (d) disqualify and/or impose penalty points on any team found to have been guilty of (i) the breach of these Rules and Regulations or road traffic rules (ii) collaboration or cheating in any manner (iii) providing a false Declaration and (iv) failing to complete the Hunt within stipulated time.
12. These Rules and Regulations may be added to or amended at the discretion of the Organiser. These Rules, all additions and amendments thereto, and instructions and rules given by the Organiser, the Trail Setter and Marshals at Briefing and during the Hunt, the interpretation thereof and the decision of the Organiser in all matters concerning the Event shall be final and binding on all participants.
